INSTRUCTIONS TO THE CANDIDATES FOR ATTENDING DOCUMENT VERIFICATION

1. This call letter is "Provisional". Candidates should note that **mere issue of this call letter does not confer on them any right** to be placed on the final panel unless they are found suitable after due verification of their candidature and all their original certificates of education, age, caste, etc. and also the original call letters, photographs and signatures, merit position and vacancy position.
2. **RRB reserves the right to reject the application/candidature** of the candidate at any stage of recruitment process in case the candidate is not fulfilling the requisite criteria and if so appointed, such candidates are liable to be removed from service summarily.
3. The venue, Time & Date of Document verification has been indicated above. Those who cannot attend on original date of Document Verification can still attend Document Verification in block dates being indicated in their call letter.
Request for **change of date and time** for document verification **will not be entertained**.
4. Candidates are requested to produce the following **original certificates/documents** for verification in support of their candidature (as applicable).
 - i. Matriculation/High School Examination Certificate or equivalent certificate (Proof for Date of Birth and Metric Qualification).
 - ii. ITI/Diploma/Degree Certificate (As applicable).
 - iii. Caste Certificate for SC/ST - Annexure-3.
 - iv. Caste Certificate for OBC - Annexure-4.
 - v. Income Certificate for Waiving Examination Fee - Annexure-7.
 - vi. Medical Certificate for Persons with Disabilities (PWD) - Annexure-9.
 - vii. NOC from serving employees/Pension Payment Order(PPO) and discharge certificate for Ex-Service Men.
 - viii. Minority declaration on Non-judicial Stamp Paper.
 - ix. **Two recent passport size colour photographs.**
 - x. **One set of attested copies of all original certificates.**
5. Candidates, who are already serving employees in any Central/State Government Department including Railways or public sector undertakings, are required to produce **No Objection Certificate (NOC)** from the employer during document verification without fail.
Note: Candidates should note that in case a **communication is received from their employer** by the RRB concerned **withholding permission** to the candidates applying for/appearing at the examination, their candidature is **liable to be rejected/cancelled**.

6. Candidates, applying against reserved vacancies (SC/ST/OBC) and/or seeking age relaxation must submit requisite **caste certificate in the prescribed format** from the competent authority (The Certificates, as applicable should be submitted during document verification). Otherwise, **their claim for reserved status (SC/ST/OBC) will not be entertained** and the candidature of such candidates, **if fulfilling all the eligibility** conditions for General (Un reserved) category, **will be considered under General (UR) vacancy only.**
7. **The result is purely provisional** and in case if any candidate is found to **have been debarred by any of the RRBs**, his/her candidature will be cancelled and **liable to be removed** from services at any later stage.
8. **If you fail to produce** the relevant **original certificates** on the date of document verification, your candidature is liable to be rejected and **no further correspondence will be entertained** from your side.
